NB: It has been agreed and accepted that minor items owned by the Parish Council, such as waste bins, will not be covered for insurance purposes. Equally some other smaller items, e.g. notice boards, gazebos, will not be insured. This decision is based on a Risk Assessment of damage and vandalism to such pieces of equipment over the past ten years. In view of the extremely low level of damage or vandalism encountered within the Parish it is felt prudent to not insure to the full replacement value, and that the Parish Council bear some of the risk. If damage or vandalism levels increase then this decision will be reviewed, and insurance levels increased as appropriate. This position to be reviewed each year, when the general Parish Risk Assessment is reviewed.
